### License conditions

"BIG Kaleidos: database" © BIG VZW

The "BIG Kaleidos database" and its constituent elements (including but not limited to the texts, the information sheets, the data, the substance lists, the structure, the layout, the graphic components, the presentation, the logos, the software, the source codes, the technical documentation, the help texts and the user guides) are protected under the different intellectual property laws, including copyright law, database law and trademark law. The "BIG Kaleidos database" and its constituent elements are the exclusive property of BRANDWEERINFORMATIECENTRUM VOOR GEVAARLIJKE STOFFEN VZW, Technische Schoolstraat 43A, 2440 Geel.

Subject to legal exceptions, not a single element of the "BIG Kaleidos database" may be partly or wholly, displayed, copied, used, distributed, notified, modified, translated, reproduced, published, transferred or saved in a retrieval system, nor may any works be created which are wholly or partly derived from the constituent elements, without BIG VZW's explicit prior written consent.

### "BIG KALEIDOS DATABASE" LICENSE CONDITIONS

#### **Article 1 - Definitions**

The following terms with capital letters have the following meaning as defined below.

"Activation date": The date on which the User license is activated as specified in the Order.

"Order": The order form signed by the Customer with a description of, among others, the number and the nature of the granted User licenses.

"User license": The use of the "BIG KALEIDOS DATABASE" as approved by BIG. The User licenses can be of different types as defined in the Order.

"Specific Conditions": The specific conditions applying to the different types of User licenses. The Specific Conditions complement these "BIG KALEIDOS DATABASE" license conditions.

"Customer": The person or business specified as Customer in the Order.

"Expiry date": The date on which the User license expires.

"BIG KALEIDOS DATABASE": The database as described in the Order.

### Article 2 - Subject

The Order, these "BIG KALEIDOS DATABASE" License Conditions and the Specific Conditions constitute the agreement between BIG and the Customer for the use of the "BIG KALEIDOS DATABASE" by the Customer.

The Customer has studied the "BIG KALEIDOS DATABASE", its composition, the method and the speed of consultation, the presentation and the limitations of the "BIG KALEIDOS DATABASE". The Customer shall make sure that only sufficiently qualified personnel will work with the "BIG KALEIDOS DATABASE". The Customer has sufficient technical information regarding the "BIG KALEIDOS DATABASE" to decide itself whether and how the "BIG KALEIDOS DATABASE" will work on its hardware and operating software.

BIG shall make a copy with the "BIG KALEIDOS DATABASE" available to the Customer upon receipt of the signed license conditions. From time to time, but usually annually, BIG shall provide an update, provided

that Customer fulfilled its payment obligations. The Customer shall use the latest version at all times. The Customer confirms that he is aware that the use of another version, other than the latest version, implies particular risks and is at his own responsibility.

New versions can take into account the new versions of the applicable operating software of the environment in which the "BIG KALEIDOS DATABASE" is used. The Customer is responsible for following these evolutions at his own expense.

#### **Article 3 - User license**

On payment of the agreed fees the Customer shall obtain a non-exclusive and non-transferable User license as specified in the Order countersigned by BIG.

The Customer guarantees that all authorised users shall respect all the provisions of these "BIG KALEIDOS DATABASE" License Conditions. The Customer shall take all necessary measures to ensure this.

The Customer guarantees that only the authorized users will have access to the "BIG KALEIDOS DATABASE" and that all authorized users will comply with all provisions of this agreement. The Customer will take the necessary measures.

The Customer is responsible for the confidentiality of the "BIG KALEIDOS DATABASE" and to safeguard the access thereto. The Customer accepts the liability of all acts performed through its accounts.

Only the partial and selective calling up of data to consult or print on paper and the partial and selective copying thereof in a word processor system, in a non-permanent way and outside any network, are authorised, within the limits of the normal usage of the "BIG KALEIDOS DATABASE" and for the sole usage of the Customer. The removal or by-passing of references to BIG and BIG logos is prohibited. The Customer is not allowed to repeatedly copy or reuse qualitative or quantitative non-substantial parts if this exceeds the limits of normal usage.

The "BIG KALEIDOS DATABASE" may only be used internally for the Customer's own activities. An exception is allowed for the provision by the Customer of very specific information to third parties if such information relates to specific calamities or imminent calamities, and for the inclusion of a limited amount of information in reports and documents required by the government.

Beyond the limits of this article the Customer is not allowed to wholly or partly copy, reproduce, or in any way change the "BIG KALEIDOS DATABASE".

The Customer is also prohibited, irrespective of the objective (commercial or not), to sell, lease, loan or distribute the "BIG KALEIDOS DATABASE", or to use it in the context of services to third parties or make it available on a network or in any other way to third parties, even free of charge.

### **Article 4 - Ownership**

The Customer acknowledges that the "BIG KALEIDOS DATABASE" is protected, and contains material that is protected, under the different laws concerning intellectual property and other rights of ownership, including but not limited to copyright and database law. The Customer acknowledges and BIG confirms that the "BIG KALEIDOS DATABASE" remains the property of, belongs to and is confidential information of BIG and that BIG has obtained all intellectual and other rights relating to the "BIG KALEIDOS DATABASE", at least obtained sufficient rights from third parties, to grant User licenses. The Customer agrees to preserve the confidentiality of the "BIG KALEIDOS DATABASE" and the content thereof.

The Customer recognizes that the BIG KALEIDOS DATABASE contains a collection of works, data or other independent elements that are systematically or methodologically ordered, and accessible separately by electronic means or otherwise, and so consist a database as described in the Law of August 31st, 1998 concerning the legal protection of databases, also in case the Customer choses to receive the BIG KALEIDOS DATABASE as data dump without the interface of BIG or in case the Customer —with permission from BIG- removes the BIG interface.

All rights not explicitly assigned to the Customer, are explicitly reserved for BIG. Also, if BIG, on recommendation of or instructed by the Customer, were to make changes to the "BIG KALEIDOS DATABASE" –free of charge or following payment– these changes shall not result in the Customer obtaining

any right of ownership or any other right to the "BIG KALEIDOS DATABASE", unless explicitly agreed otherwise in writing.

The Customer undertakes, on receipt of a new version or on termination of the agreement with BIG, to destroy (full destruction of all temporary and permanent files, including from cache and other temporary memories and from all environments and applications) all previous versions (and all versions in case of termination of the agreement) of the "BIG KALEIDOS DATABASE" and to notify such destruction to BIG by registered mail. If BIG did not receive this registered mail within 30 days after delivery of the new version or termination of the agreement (post date of the registered mail), the discount granted for new versions falls due and this amount will still be invoiced by BIG.

The Customer will not analyse or use, whether it be for own use, for resale or to produce similar products, any part of the "BIG KALEIDOS DATABASE", unless the use is in agreement with the use as foreseen under these conditions.

The Customer undertakes not to use any means, software or routines in order to breach or circumvent BIG's security measures or to make their function inappropriate in another way.

### **Article 5 - Price and payment**

The price for the deliveries is paid as specified in the Order.

The price for the annual update is calculated based on the purchase price which is indexed annually based on the index of consumer prices multiplied by the percentage of the granted discount. BIG is entitled to adjust the price above this indexation. In this case the Customer has the right to terminate his subscription within a month after the announcement of BIG of its intention to increase the price above the index correction.

If owed amounts are not paid within fifteen (15) days after the due date, BIG, by operation of law and without notice of default, is entitled to interest on all owed amounts from the due date to the date of effective payment, to the amount of ten (10) percent annually, as well as fixed damages to the amount of ten (10) percent of the unpaid amounts. Any granted discounts shall fall due in this case.

#### Article 6 - Term and duration of the User licenses

The agreement between BIG and the Customer comes into force on the date of the signing of the Order by the Customer for an indefinite period of time. The agreement can be terminated by either party subject to notification by registered letter at the latest three months prior to the expiry date of the current User licenses.

Every User license is valid for one year from the Activation date and is then extended with annual periods. BIG provides the Customer with an activation code of the "BIG KALEIDOS DATABASE" which enables the User licenses as specified in the Order. Every activation code is valid for one year. Also if the Customer delays entering the activation code provided by BIG, the annual term of the granted User licenses expires.

In case of late payment by the Customer, BIG is entitled to not provide the (new) activation code to the Customer until full payment of the outstanding amounts, including interest and costs. The then running annual term of the User licenses is not suspended as a result hereof.

BIG can terminate the granted User licenses without observing a period of notice, subject to notification by registered letter, when the Customer:

- becomes insolvent, is declared bankrupt, files for bankruptcy protection, suspends its activities, or is winded up
- for more than thirty (30) days after written notification fails to remedy a breach of one of the provisions of this agreement

The Customer knows and accepts that the "BIG KALEIDOS DATABASE" shall no longer work after the expiry date, unless a new activation code is entered. The Customer will be reminded of this by a warning procedure and can at all times consult the expiry date via the "BIG KALEIDOS DATABASE" under the Info tab on the home page. BIG is not liable for the unavailability of the "BIG KALEIDOS DATABASE" after the expiry date. The Customer who does not pay his fee or does not extend the license does so at his own risk, but in emergency situations can contact BIG 24/7 at the emergency number +32 (0)14 58 45 45 at the rates

applicable at that time.

#### **Article 7 - Territorial restrictions**

The "BIG KALEIDOS DATABASE" and the information contained therein are intended for use within the European Union and Switzerland alone. The Customer may not directly or indirectly use the "BIG KALEIDOS DATABASE" outside the European Union and Switzerland.

If BIG as a consequence of the use of the "BIG KALEIDOS DATABASE" by the Customer becomes liable or must defend itself against an alleged liability in a jurisdiction outside the European Union or Switzerland, the Customer shall indemnify BIG against all negative consequences, including the repayment of lawyers' fees.

### **Article 8 - Liability**

BIG is not liable for the use, or the consequences of this use of the "BIG KALEIDOS DATABASE" by the Customer, nor for the possible unsuitability of the "BIG KALEIDOS DATABASE" for the Customer's specific needs.

BIG warrants that the "BIG KALEIDOS DATABASE" has been developed according to the generally accepted industry standards. However, BIG doesn't warrant that the "BIG KALEIDOS DATABASE" is entirely free of bugs or mistakes, but only that those do not impair the use by the Customer.

THE CUSTOMER EXPLICITLY ACKNOWLEDGES USING THE "BIG KALEIDOS DATABASE" AT HIS OWN RISK.

The "BIG KALEIDOS DATABASE" is provided "as it is" and as it is known to the Customer. BIG does not warrant that the functions contained in the "BIG KALEIDOS DATABASE" will meet Customer's performance requirements or that the "BIG KALEIDOS DATABASE" will operate in accordance with Customer's expectations. Customer acknowledges that before purchasing the "BIG KALEIDOS DATABASE", Customer has studied the "BIG KALEIDOS DATABASE" and its performance. Therefore, Customer accepts the responsibility for the selection of the "BIG KALEIDOS DATABASE", its use and the results to be obtained there from. Except as expressly provided for in this agreement, BIG makes no warranty of any kind, express or implied, and the warranty of fitness for a particular purpose is hereby excluded.

Under no circumstances shall BIG be liable for any indirect damages to the Customer. Direct damages shall be compensated by BIG by restitution in kind (e.g. delivery of a new data carrier). If a possible non-performance on the part of BIG is not restituted in kind, the Customer needs to prove any direct damages he suffered.

Under no circumstance shall BIG, annually, be liable for an amount in excess of half the total amount invoiced by BIG to the Customer and effectively paid by the Customer to BIG for the last delivery of the "BIG KALEIDOS DATABASE" by BIG.

Under no circumstance can the Customer enforce any claim against BIG after a period in excess of ten months after the damage occurred.

In no way whatsoever third parties can claim any damages from BIG based on this agreement or in any other way. If BIG is held liable vis-à-vis third parties based on information from the "BIG KALEIDOS DATABASE" provided by the Customer to these third parties or used for third parties, and BIG needs to pay damages to these third parties, the Customer shall compensate BIG and indemnify it for the part of the damages that BIG would not have had to pay if the third parties were bound by the provisions of this agreement.

### Article 9 - Infringement

With every breach by the Customer of the obligations specified in articles 3 and 4 of these License conditions or the legal protection of BIG's rights, fixed damages are owed to the amount of ten times the invoice amount over the last year of the User licenses as specified in the order, by operation of law and without prior notice of default, without prejudice to BIG's right to claim higher damages.

If the Customer has started a trade personally, directly or indirectly, or through a company or joint venture, in

which he has an interest and irrespective of the size of that interest, among others with illegal copies, the illegal operation of the software, the database and/or the content of the "BIG KALEIDOS DATABASE" or derivative works thereof, the amount of the fixed damages is raised to € 500,000.00, without prejudice to BIG's right to claim higher damages.

The Customer acknowledges that the amounts of these fixed damages are justified, among others because of the substantial investments and the work required for the development and compilation of the "BIG KALEIDOS DATABASE", among others for updating, obtaining, verifying and presenting the content. The Customer therefore explicitly acknowledges that these fixed damages only cover part of the damages which may arise to BIG because of the Customer's shortcomings regarding the obligations specified in the preceding articles.

The parties agree that a breach of the provisions of BIG's legal rights or of articles 3 and 4 constitute a serious shortcoming on the part of the Customer, which results in the immediate termination of the User licenses, irrespective of BIG's right to damages.

### Article 10 - Reporting and audit

In order for BIG to control the Customer's use of the "BIG KALEIDOS DATABASE", it can be provided in the Order that the Customer should report to BIG as defined in the Order.

In order to verify if the Customer uses the "BIG KALEIDOS DATABASE" within the authorized limits, BIG is entitled at all times to perform an audit on the Customer's use of the "BIG KALEIDOS DATABASE". BIG can perform such audit itself or through a third party.

The Customer will provide within 24 hours after request all necessary and useful documents, documentation and files and will allow access to its buildings during working days and woring hours upon notice of half a day.

Upon breach of this Agreement all costs related to the audit will be paid by the Customer and will be reimbursed to BIG upon first request, irrespective of BIG's right to damages.

In order to improve the services, BIG collects information concerning the hardware of the Customer and the use of the "BIG KALEIDOS DATABASE" by the Customer. This information will not be shared with third parties.

### Article 11 - Transferability

BIG is entitled to transfer its rights and/or duties in the agreement with the Customer to a third party, without prior notification or consent of the Customer. The Customer does not have this right without BIG's prior written consent.

### **Article 12 Applicable law and competent court**

This "BIG KALEIDOS DATABASE" License is governed by Belgian law. In case of dispute, the courts of the district of Brussels (Belgium) have exclusive jurisdiction to hear any disputes (Dutch chamber). Nevertheless, BIG also has the right to summon the Customer before the court where the Customer is established.

### Installation


To execute the installation you have to be logged on as a user with administrator rights.

- Installation of the database


Follow the steps below in order to install the program.

- Select the language that Setup uses during installation + OK



Print screen will appear in which the sections can be indicated that need to be printed.






## Search via Formula

For organic substances the formula consists of consequently the number of C-atoms, then the number of H-atoms and finally all other elements in alphabetical order. For inorganic substances the most common formula is used. For the hydrates the number of water molecules is added after the formula after a dot (e.g. Nal.2H2O). Always type the elements in using capitals. When an element consists of 2 letters, the 1st is a capital and the 2nd is small print (e.g. Na).

Search via Formula can be done by selecting Formula in the pop-up menu.






## Search by CAS No.


# **Working with sheets**

More than one product can be retrieved simultaneously.


E.g. You search for a product by Product No.




Then this product will appear on a sheet.



When you search for another product it will appear on a second sheet or third sheet




The active sheet will appear to be lying on top.




You can retrieve different sections of different products. Each sheet is a different product.

In order to retrieve different sections of the same product you can open the CD multiple times.




A number of operations can be done on the sheets:

By clicking on you will see a menu with Products.




You can close the active sheet by clicking on






You can also choose for following position of the sheets:

#### New horizontal group




### you will get next result




You can go back to the vertical group through the right mouse button.
